





## **ERASMUS+ KA131 2025 PROJECT PLACEMENT RESULTS**

Information regarding the 2025 Erasmus+ KA131 Student Mobility Project study placement and internship ranking results and the procedures to be carried out are below.

- 1. Placement results are not the results of grant distribution. Grants are finalized after the annual contribution agreement to be made between the European Union and the Republic of Turkey, and this agreement has not been signed yet. After this agreement is signed, a grant agreement will be signed between the Turkish National Agency and Istanbul Medipol University, and the amount of grant allocated to our University will be finalized. (Note: There is no separate application process for the grant. It will be evaluated according to the successful ranking.) Once the amount of grant to be allocated to our University is finalized, additional information will be provided regarding the grant distribution. It is anticipated that this process will take place after July. Students who want to participate in the mobility before the grant distribution is finalized must benefit from the mobility without a grant.
- 2. Announcements, notifications and correspondences made by the Erasmus Institutional Coordination Office are made via our students' "std.medipol.edu.tr" e-mail address. Therefore, it is very important for our students to check their "std.medipol.edu.tr" e-mail addresses regularly.

## 3. Procedures and Calendar

## a. Procedures for Students Entitled to Educational Mobility

Our students who are entitled to Study Mobility will be able to study at universities that Istanbul Medipol University has an agreement with within the scope of the Erasmus+ program. The first thing that needs to be done is to contact the university where our students are placed and complete the nomination process. This process is carried out by the Erasmus Institutional Coordinatorship.







As part of this process, we first contact the host university where the selected student has been placed and provide them with the necessary information, requesting them to accept our nominee. Once we receive confirmation of acceptance from the host university, the student submits the required documents, which we then forward to the host institution. This completes the nomination process. The nomination process is carried out first for students participating in the Fall semester mobility, followed by those joining in the Spring semester. In rare cases, the host university may decline to accept our nominee. If this happens, we guide the students toward an alternative university.

At the initial stage, the most critical issue for our students is the timely withdrawal of those who decide not to participate in the study mobility. Students who wish to withdraw must notify us via email at erasmus@medipol.edu.tr no later than April 10, 2025. If a student withdraws after the nomination period has begun, the host university's nomination deadline may have already passed. This could prevent our substitute students from taking their place. After the grant results are announced, a short window will be provided for students who did not receive a grant and wish to withdraw. During this period, waiver petitions (voluntary withdrawal declarations) will be collected from those who choose not to participate. If a student does not submit a waiver petition but later decides not to participate, their total score in next year's Erasmus mobility application will be affected. According to the relevant regulations, 10 points will be deducted from their total score.

An orientation/information meeting will be held for students who have been selected for Erasmus mobility. This meeting will cover essential details about the process and important deadlines. Attending the meeting is highly important to ensure a smooth mobility experience without any disruptions. We encourage all students to prepare their questions in advance and take notes on any uncertainties they may have so they can ask them during the session

## b. Procedures for Students Qualified for Internship Mobility

Students who are selected for Erasmus internship mobility are responsible for finding their own internship placement and obtaining an acceptance/invitation letter from the host institution. Some institutions refer to this document as an acceptance letter, while others call it an invitation letter, depending on their internal procedures. Students must submit their internship acceptance/invitation letters to erasmus@medipol.edu.tr no later than November 1, 2025.

Students who wish to withdraw from internship mobility must submit their waiver petitions via email to erasmus@medipol.edu.tr by April 10, 2025, at the latest. If a student withdraws after this date, there is a possibility that the mobility of our substitute students may be affected. After the grant results are announced, a short deadline will be set for students who did not receive a grant and wish to withdraw. During this period, waiver petitions will be collected from those who do not want to participate. If a student does not submit a waiver petition but later withdraws, their total score in their next year's Erasmus mobility application will be affected. According to the relevant regulation, 10 points will be deducted from their total score (Click here for the Waiver Petition Sample).

The Erasmus+ 2025 project will start on June 1, 2025, and end on July 31, 2027. The acceptance/invitation letters that students receive must be dated within this period. 4th-year students who plan to participate in Erasmus+ internship mobility after graduation must complete their internship within 12 months from their graduation date. Students who receive an acceptance/invitation letter should not wait until the final deadline to submit it to the Erasmus Institutional Coordination Office; instead, they should send it as soon as possible. An orientation/information meeting will be held to explain the procedures and share important dates with students who have been selected for internship mobility. Attendance at this meeting is highly important to ensure a smooth mobility process without any disruptions. We strongly recommend that students take note of any questions they may have regarding the procedures and ask them during the meeting. Internship Mobility Orientation Meeting Dates:
